- In the absence of a doctoral degree : hold a Master's degree in taxation or another relevant discipline **and** have 10 years of professional experience in Canadian tax planning, Canadian tax compliance, international tax planning, or indirect taxes.

- Demonstrated strong interest and aptitude for teaching and university pedagogy, including new pedagogical practices involving AI and those applicable to distance learning.
  - Demonstrated strong interest in disciplinary and interdisciplinary research, development, and innovation.
